#### MAPPING CRM → FRBR

Foreword to version 0, released on January 29th 2003:

This is the first draft version of a mapping from CRM to FRBR. It is intended to serve as a counterpart of the mapping from FRBR to CRM that was released by late December 2002. The aim is to test the robustness of both CRM and FRBR, and to test their potential interoperability. A more specific use of this mapping could be to ensure that CRM-compliant descriptions of museum or library materials could be understood in FRBR terms and automatically converted into entries in a library catalogue, or to display museum and library catalogue entries on the same OPAC (provided the museum catalogue is CRM-compliant and the library catalogue is FRBR-compliant).

In the "traditional" bibliographic universe, information is split into "bibliographic records" and "authority records". FRBR only deals with bibliographic records and FRANAR will deal with authority records. There is no such separation in CRM and all elements of interest in the museum universe of discourse are handled by CRM. Until FRANAR is finished and made public and the whole "bibliographic universe" is covered by the "FRBR+FRANAR" model, this mapping is necessarily incomplete; hence the mention "Out of scope of FRBR; pertains to the scope of FRANAR" for a number of properties.

This mapping is based on version 3.4 of CRM.
